

## Research at Harvard Vanguard Medical Associates: Focusing on What Works

Research and teaching have been central to the mission of Harvard Vanguard Medical Associates throughout its history. "As a non-profit medical group, we have a special commitment to advancing knowledge about what works in health care, as well as training future generations of medical professionals," says Richard Marshall, MD, director of the Harvard Vanguard Office of Clinical Research. "We participate

in research so that our learning will benefit the general public, as well as our individual patients. Research keeps us focused on what actually works—helping us continually improve the care we deliver. And research also helps us to attract and retain excellent staff who want to be part of a learning organization."

Harvard Vanguard clinicians are able to engage in research in addition to their time devoted to patient care, due to fruitful collaborative relationships with outside researchers. Through these joint research efforts, Harvard Vanguard clinicians expand their access to expertise and research studies that focus on areas of interest to the practice, and then bring new knowledge and skills back to their patients.

The majority of Harvard Vanguard's research collaborators come from the Harvard Medical School's Department of Ambulatory Care and Prevention, which also receives support from Harvard Pilgrim Health Care. Recently, however, Harvard Vanguard has expanded its research partnerships to include other Harvard departments, as well as Brigham and Women's Hospital. Joint research projects include clinical trials of new medications or approaches to medical care, as well as research about health services in general, investigating how best to provide care to large groups of patients.

For staff interested in clinical research, the Office of Clinical Research is an important resource to link Harvard Vanguard staff and outside investigators who have similar interests. "We participate in research projects that contribute to the long-term strategic goals of Harvard Vanguard, as well to the career development of our staff," says Marshall. Working with Marshall are Calvin Cohen, MD, who leads clinical trials, Anita Chan, who leads management and business services related to research, and Amy Marston, project manager.
